WHEREAS, the gross taxable value for operating purposes not exempt from taxation within South Walton County has been certified by Walton County Property Appraiser to the South Walton County Mosquito Control District as \$38,473,537,913.

NOW, THEREFOR, BE IT RESOLVED by the South Walton County Mosquito Control District of South Walton County, Florida, that:

• The Fiscal Year 2024-2025 operating millage rate is 0.2245 mills per \$1,000.00, which is greater than the rolled-back rate of .1931 mills per \$1,000.00 by 16.26%.
